## On the Evening

Parents are welcome to arrive from **4:20 PM** and should enter via **Student Reception**, where you will be greeted and signed in. Refreshments will be available in our **Block B canteen**, providing an opportunity to relax before your appointments begin. All meetings will take place in **Block B**, and clear signage will be in place to help you navigate the location of staff. Appointments with staff will be held in one of three rooms – the library, the hall and the sports hall. All these rooms are next to each other. You will also receive a map and a **paper copy of your child's most recent report** upon arrival.

We strongly encourage students to attend alongside their parents or carers, as these conversations are most effective when everyone is involved.

## Separate Appointments

We understand that in some circumstances parents may prefer to have separate appointments from their child's other parent or carer. While we will always try to support families where possible, please be aware that arranging separate appointments significantly reduces the number of available slots for other students.
